



# PILGRIMAGE TO THE HOLY LAND

## **Day 1 - Oct. 17: Depart USA**

Our pilgrimage begins today as we depart on our flight to Israel. Meals and drinks served aloft.

## **Day 2 - Oct. 18: Arrive Tel Aviv / Jerusalem**

After arrival at Ben Gurion Airport in Tel Aviv we will be met by our local guide who will accompany us through our pilgrimage and make the scripture come alive as we follow in the footsteps of Jesus. Drive to our hotel in Jerusalem.

## **Day 3 - Oct. 19: Jerusalem**

This morning we will drive to Bethlehem where we will visit and celebrate Mass at the Nativity Church which was built by the Emperor Constantine in the 4th century above the traditional Grotto of Jesus' birth. Also tour the Manger, the Grotto of St. Jerome, the Church of St. Catherine, the Milk Grotto and the Shepherds' Field.



## **Day 4 - Oct. 20: Jerusalem**

This morning we will drive to the top of the Mt. of Olives for a spectacular view of Jerusalem. Visit the Church of Pater Noster where Jesus taught the Lord's prayer to his Disciples and the Chapel of Ascension where Jesus ascended into Heaven forty days after his resurrection. Then walk along the "Palm Sunday Road" to Dominus Flevit where Our Lord wept over Jerusalem. Continue to the Garden of Gethsemane and the Church of All Nations for Mass on the Rock of Agony. We will then proceed to the Israel Museum in the New City of Jerusalem where we will see a scale model of Jerusalem as it appeared 2,000 years ago. Then continue on to Ein Karem to see the Visitation Church where Mary proclaimed her famous "Magnificat" and the Church of St. John the Baptist where St. John the Baptist was born.

## **Day 5 - Oct. 21: Jerusalem**

This morning we will enter the Old City of Jerusalem through St. Stephen's Gate. Visit the Church of St. Anne where the Blessed Virgin Mary was born, the Pool of Bethesda where Jesus healed the paralytic man, the Chapel of Flagellation,

Lithostrotos, and Arch of the "Ecce Homo". Then follow the Via Dolorosa to the Church of the Holy Sepulchre to visit Golgotha and the Tomb of the Risen Savior. We will conclude the day with a visit to the Latin Patriarchate where members of the Equestrian Order of the Holy Sepulchre will receive their Pilgrim Shells.



## **Day 6 - Oct. 22: Jerusalem**

This morning we will view the Temple Area of the Old City of Jerusalem featuring the Dome of the Rock, el Aqsa Mosque and the Wailing Wall. We will then enter the restored Jewish Quarter and walk along the excavated Cardo, once a main street of ancient Jerusalem. Enjoy touring the Herodian Mansions, a complex of villas from 2,000 years ago. This afternoon, drive to Mt. Zion to visit the Upper Room where Jesus celebrated the Last Supper, Dormition Abbey where Mary fell into eternal sleep, and St. Peter in Gallicantu where Peter denied Jesus three times.



## **Day 7 - Oct. 23: Jerusalem**

After an early morning Mass at the Church of the Holy Sepulchre we will return to our hotel for breakfast. Following breakfast, proceed to Bethany to visit the site of the home of Mary, Martha & Lazarus and the Tomb of Lazarus. Continue through the Judean Wilderness and along the shores of the Dead Sea to Masada where we will take an exciting ascent by cable car up to this last stronghold of the Jewish Zealots in their war against the Romans in 73 A.D. We will then make a

stop at Qumran to visit the site where the Dead Sea Scrolls were discovered. This evening a special "Farewell Jerusalem" dinner will be arranged in our honor at a typical Middle Eastern restaurant.

### Day 8 - Oct. 24: Jerusalem / Tiberias

Depart Jerusalem and drive to Jericho, the oldest known city in the Western world, where we will visit the ancient "tel" and Elisha's Fountain. We will then take a cable car up the Mount of Temptation to the site where Jesus was tempted by the devil. Then proceed a short distance to the traditional Baptismal Site on the Jordan River where we will have an opportunity to renew our baptismal vows. Continue our drive north through the Jordan River Valley to Tiberias for check-in at our hotel located on the shores of the Sea of Galilee.



### Day 9 - Oct. 25: Tiberias

This morning we will enjoy a scenic boat ride across the Sea of Galilee to Capernaum, home of Our Lord during his ministry. After visiting the synagogue where He taught, proceed to Tabgha, site of the multiplication of the loaves and fishes, and to the nearby Church of the Primacy of Peter. Then drive up to the Mt. of the Beatitudes for Mass at the site of the Sermon on the Mount. This afternoon, ascending the Golan Heights we'll stop at the Banias Spring that rises from under a cave and is one of the sources of the Jordan River. It was here near Banias at ancient Caesarea Philippi where Peter made his confession of faith in Jesus.



### Day 10 - Oct. 26: Tiberias

Following breakfast, we will drive to Cana of Galilee, where Our Lord performed the first miracle - changing water into wine at the wedding feast. Here, we'll invite couples to renew their wedding vows. We will then proceed to Our Lord's boyhood town, Nazareth. Here we will celebrate Mass at the Basilica of the Annunciation, visit Joseph's Workshop and Mary's Well. Then take an excursion to the summit of Mt. Tabor to see the site of the Transfiguration of Jesus.

### Day 11 - Oct. 27: Tiberias / Tel Aviv

This morning we will depart Tiberias and drive to the sparkling port city of Haifa where we will ascend Mount Carmel, home of the prophets Elijah and Elisha, for Mass at Stella Maris. Then continue along the Mediterranean coast to ancient Caesarea where St. Peter preached and St. Paul was imprisoned for two years. Here we will visit the ruins of the Roman Theater, the Crusader's Moat and the Byzantine Churches. Our drive continues to Old Jaffa where we will visit the Church of St. Peter, the home of Simon the Tanner. We will then enjoy a farewell dinner including wine at a local restaurant and then transfer to the airport in Tel Aviv to catch our late evening return flight home.

### Day 12 - Oct. 28: Tel Aviv / USA

Today our Holy Land pilgrimage comes to an end as we arrive back home following our overnight flight from Tel Aviv.

## GENERAL INFORMATION AND CONDITIONS

**Reservations and Payment:** Please complete the attached Reservation Application and return it with your deposit of \$300.00 per person at the time of booking. Final payment is due 65 days prior to departure.

**Cancellations:** All cancellations must be in writing. Cancellations received after 5PM Pacific Time or on weekends/holidays will be processed the next business day. The following per person cancellation charges will apply: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 61 days prior to departure, \$250.00 will be charged. If canceled 60 - 31 days prior to departure, \$450.00 will be charged. If canceled 30 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.

**Refunds:** Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

**Trust Account Disclosure:** California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

**Travel Consumer Restitution Corporation ("TCRC"):** George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if the Seller of Travel was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which the Seller of Travel failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to the Seller of Travel, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.

**Travel Documents:** A passport with a minimum of 6 months validity remaining is required of all U.S. citizens. U.S. citizens do not require visas for entry to Israel. If you are not a U.S. citizen, please call to find out if you need a visa. George's International is not responsible for individual visas or passports.

**Tour Cost:** All quoted prices are based upon fares, tariffs and currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 30 tour members not be reached, the right is reserved to increase the tour cost accordingly.

**Tour Documents and Tickets:** Final tour documents are mailed, provided we have received full payment, within 3 weeks of departure.

**Baggage:** Each passenger is allowed one checked bag and one carry-on. You will be responsible for paying to the airline any additional charges for additional checked baggage or overweight baggage (if excess weight is permitted). George's International Tours is not responsible for lost, damaged or stolen baggage.

**Air Transportation:** Air travel is in economy class on United Airlines (or any other IATA carrier). Fares are based upon levels in effect at the time of printing. Fares and flight schedules are subject to change without notice.

**Hotels:** Accommodations are based on double occupancy rooms. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

**Travel Insurance:** We strongly recommend that you have comprehensive travel insurance. Insurance may be purchased directly through George's International Tours and registration forms will be provided upon receipt of your deposit or you may purchase online at [www.georgesintl.com](http://www.georgesintl.com). ### COVID-19 POLICY

#### ISRAEL

Please be aware that George's International Tours currently requires all participants on this pilgrimage to be fully vaccinated with one of the CDC-approved vaccines as per the regulations adopted by the government of Israel. A person is considered fully vaccinated two weeks after receipt of the second dose in a two dose series of the Pfizer-BioNTech and Moderna vaccines or two weeks after receipt of a single dose of the Johnson & Johnson vaccine provided that it does not become more than 180 days since you became fully vaccinated at any time during your stay in Israel. In the event that your two dose regimen of Pfizer-BioNTech and Moderna or one dose regimen of Johnson & Johnson will be older than 180 days at any time during your stay in Israel, you will be required to obtain a booster shot at least two weeks prior to your arrival in Israel. In the event that Israel's definition of being fully vaccinated changes in the future we will update our policy to reflect that.

We will ask you to provide proof of your COVID-19 vaccination status approximately four months prior to departure and failure to do so will result in your removal from the trip (with cancellation penalties assessed) unless you are able to provide evidence of an upcoming vaccination appointment and subsequent proof of your vaccination status no later than one month prior to departure.

While it is possible that the government of Israel may relax the requirements for a vaccination in the future or provide for exemptions to the vaccination requirement, George's International Tours reserves the right to require that all participants on this pilgrimage be fully vaccinated at the time of travel for the safety of our clients as well as our contracted staff overseas. There will be no exceptions made to this vaccination policy for religious or health reasons.

The Israeli government currently requires that you provide evidence of a negative COVID-19 PCR test which was taken within 72 hours of your departure for Israel and obtaining this test and the associated cost will be your responsibility.

Upon arrival in Israel you will need to take a second COVID-19 PCR test at the airport and will then go into a limited isolation at your hotel until you receive a negative test result which generally is obtained within a few hours. There are no activities planned for your arrival day except for dinner at your hotel, so this limited isolation should not have any impact on the sightseeing outlined in your itinerary.

The United States government currently requires that you show evidence of a negative COVID-19 antigen or PCR test which was taken one day prior to your return to the United States before you are allowed to board your return flight home.

George's International Tours will assist you in procuring the COVID-19 PCR and antigen tests required upon arrival in Israel and before departure back to the United States, however the cost of these tests will be your responsibility and are expected to be approximately \$100.00 per person (subject to change).

If at any time you become symptomatic of COVID-19 during your pilgrimage we will require that you undergo testing at your own expense as per the laws in each country you are visiting. In the event that you test positive for COVID-19 during the course of your pilgrimage you will be required to go into isolation at your own expense at an official Israeli government COVID isolation facility and for the safety of the other participants you will no longer be allowed to continue with the pilgrimage.

Purchasing comprehensive travel insurance that covers medical treatment for COVID-19 while overseas will be mandatory. Information on the policies we offer is available at [georgesintl.com/travel-insurance](http://georgesintl.com/travel-insurance) or you may purchase a policy through a third party if desired.

The entry/exit requirements for Israel and the United States are subject to change and we will notify you of any new regulations that may affect your journey.

We would like to remind you that George's International Tours only acts as an intermediary between you and the other travel suppliers (airlines, hotels, etc.) and in no way assumes responsibility for any COVID-19 related requirements that travel suppliers and governments may impose due to the current pandemic or for any other unforeseen reason.
